Professor Asha Singh Kanwar, one of the world's leading advocates of learning for development, became President and Chief Executive Officer of the Commonwealth of Learning (COL) in June 2012. Before joining COL, Professor Kanwar was a consultant in open and distance learning at UNESCO's Regional Office for Education in Africa. Her engagement with distance education began when she joined Indira

Gandhi National Open University (IGNOU) as Director of the School of Humanities and Pro-Vice Chancellor. This assignment was the stepping stone to a career with over 35 years of experience in teaching, research and administration. She has written, edited and co-edited a dozen books, published over 50 papers and articles and has also delivered several keynotes at prestigious international conferences. A recipient of several awards and fellowships, Professor Kanwar received her undergraduate, Master's and MPhil degrees from the Panjab University in India and a DPhil from the University of Sussex. She was a Fulbright Fellow for post-doctoral research at Iowa State University, where she was later invited to teach. She received the International Council for Open and Distance Education (ICDE) Prize of Excellence and the Meritorious Service Award for outstanding contributions in open and distance education from the Asian Association of Open Universities. Professor Kanwar has also been conferred six honorary doctorates from universities in Asia, Africa and Europe.

Dr. Jason Laker is a Professor of Counselor Education and former Vice President of Student Affairs at San José State University in California; and Affiliated Research Faculty with the Center for Research and Education on Gender and Sexuality at San Francisco State University. Jason previously served as AVP/Dean

of Student Affairs and Faculty of Gender Studies at Queen's University (Canada). He holds a Ph.D. from the Center for the Study of Higher Education at the University of Arizona, an M.A. in Community Counseling from Adams State University, and a B.S. in Organizational Communication from Central Michigan University. He has published four edited books, one each in U.S. and Canada, regarding gender and men's development; and two with Palgrave Macmillan UK in 2014: *Citizenship, Democracy and Higher Education in Europe, Canada, and the U.S.,* and *Civic Pedagogies in Higher Education: Teaching for Democracy in Europe, Canada, and the U.S.* His international activities include serving among 11 individual IAU Associate Members, and the only North American on the editorial board of the Expertise Publications Program of the European Training Foundation (an agency of the European Union).

Dr. Alex Manus is currently the Assistant VP for Academic Quality, Accreditation and Support at Southern New Hampshire University (SNHU). Dr. Fengchun Miao is leading UNESCO Education Sector's programmes in areas of ICT in education policy planning and development, ICT competency standards for teachers and students (ICT CFT), Open Educational Resources (OER), mobile learning and AI for education, and future e-schools. He is also in charge of

UNESCO Prize for the Use of ICTs in Education. Under her competence, he is coordinating the cooperation with other UN-agencies in the field of ICT for SDGs.

He has launched the following major ICT in education events of UNESCO: International Conferences on ICT and SDG 4 which has been convened twice (2015 and 2017), UNESCO Mobile Learning Weeks (for seven years consecutively since 2011), Asia-Pacific Ministerial Forums on ICT in Education which has been organized for five times since 2010, and African Ministerial Forums on ICT in Education which has been organized twice. He has been leading the development of the following major documents of UNESCO: 2015 Qingdao Declaration and the 2017 Qingdao Statement, UNESCO Global Policy Guidelines on harnessing ICT for achieving Education 2030, UNESCO ICT in Education Policy Toolkits, and OER Indicators. He has been co-leading the development of UNESCO ICT Competency Framework for Teachers (ICT CFT) and Mobile Learning Policy Guidelines. He has directly planned and organized more than 30 workshops on ICT in education policy development for more than 1000 policy makers from over 50 countries, and 15 workshop on OER policy development for more than 20 countries.

Before joining UNESCO, Dr. Miao was the Director-General of the National Research Centre for Computer Education, Ministry of Education, China. In that capacity, he was responsible for the development of ICT in education policy and ICT curriculum standards for students and managing the National Association for the Use of ICT in K-12 Schools of China. Highlights of his achievements during that period include National Guidelines for Curriculum Reform for China K-12 Schools, National ICT in Education Master Plan 2005-2010, ICT Curriculum Standards for Students (K-12), China Educational Technology Standard for Teachers, and five series of ICT textbooks for students.

### Olive Mugenda

Former Vice-Chancellor, Kenyatta University, Kenya and Executive Director and Founder, Centre for Innovative Leadership & Governance

Prof. Olive Mugenda is the former Vice-Chancellor of Kenyatta University, a centre of excellence in higher education in Africa. Before becoming Vice-Chancellor, Prof Mugenda had had a long and eventful career in education. The journey began in 1979, when she graduated with a first class honours degree in

education from the University of Nairobi. She later did a Master of Science degree and PhD in Family and Consumer Sciences and a PhD at Iowa State University (USA). She is also a holder of a Master of Business Administration (MBA) from the Eastern and Southern Africa Management Institute. She taught at Kenyatta University for many years, rising to various leadership positions including Chairman of Department, Dean and Deputy Vice-Chancellor (Finance, Planning & Development). She entered the history books as not only the first woman Vice-Chancellor of a public university in Kenya but also in the East Africa region. Since taking over the mantle in 2006, Prof Mugenda has transformed Kenyatta University by consistently aligning most activities to its vision: To be a dynamic, inclusive and competitive centre of excellence in teaching, learning, research and service to humanity. She calls this 'transformative leadership', which is aimed at making KU a globally competitive university and a centre of academic excellence. Prof Mugenda then identified a team of champions, including management and board of directors, and got them to embrace the university's new strategic vision and plan.

Felicia Nkrumah is currently the Communications and Publications Officer of the Association of African Universities (AAU) where she is responsible for managing the corporate communications portfolio of AAU. Licia Sbattella, PhD – Bioengineer, Clinical Psychologist and Psychotherapist is Associate Professor of "Natural Language Processing: text and voice analysis" at Politecnico di Milano. Since 1991 she has been involved in national and

international academic research and teaching activities in Italy, France, Spain, Switzerland, and Canada even in cooperation with UN, UNESCO and IAU. Since 2007 she is member of the Program Committee of UN-G3ict (the Global Initiative for Inclusive ICTs) and works internationally with projects for the dissemination and implementation of the principles outlined by the Declaration on the Rights of Persons with Disabilities adopted by the UN in 2007. She is Expert Member of the Pontificia Academia Pro Vita and she published several books and articles in international journals and conference proceedings. Since 1983 she is Scientific Director of Esagramma, a clinic and research center for autism and intellectual disability based in Milano.

In his capacity as Secretary General he worked towards ICDE's vision "to be the global facilitator for inclusive, flexible, quality learning and teaching in the digital age". Gard is a member of the Governing Board for the UNESCO Institute for IT in Education, the Editorial Advisory Board of the Indian Journal of Open Learning and

the Editorial board of the American Journal of Distance Education. ICDE publish the platinum open access journal Open Praxis.

Gard joined ICDE in 2011 after serving at the Nordic Council of Ministers, NCM, in Copenhagen, Denmark, as director for the Department of Knowledge and Welfare. He managed the secretariat for several configurations of ministers including the ministers for education, research and IT, the ministers for health and social affairs, the ministers for labour affairs, for a shorter period the ministers for enterprise and the ministers for finance. Before joining the NCM, Gard served as Research and IT Counsellor for Norway, and as member of the executive team for the Norwegian delegation to the European Union. Prior to this, Gard was a senior official in the European Commission in Brussels, Directorate General Information Society. In Norway Gard worked for the Norwegian Government in research and development agencies.

He has held several academic posts including the Open University, Nottingham University and Imperial College. From 2001-2007 he was appointed chief

He was elected as a fellow of the Royal Academy of Engineering in 1999 and made a Commander of the British Empire in 2007 for "services to science," In 2010 he was made an "Officer of the Order of Merit of the Federal Republic of Germany." Among his honorary doctorates he holds one from the Technical University of Cluj-Napoca in Romania and is an honorary citizen of that City

From 2007 to 2013, he has been appointed as the director of Iranian Research Institute for Information Science and Technology by the minister of Science, Research and Technology where he was coordinating all related projects in the field of scientific and technological information. He has initiated several national projects including: A national current research information system, The national repository of Electronic Theses and Dissertations, The council on providing scientific resources, and The Commission of Science and Technology Information System. His research interests include system level digital vlsi design, IT governance, eLearning, big data and cloud computing.
